Following the sale of the Village Hydro utility, a portion of the funds was used to build a new Wyoming Fire Hall on Main Street in Wyoming, and the balance invested with the incorporation of the Wyoming Community Foundation.</p> <p>Since its inception in late 2000, the Foundation has donated a total of nearly \$400,000 to the community in response to requests submitted for various projects from year to year. (list of groups receiving donations listed under Groups Supported)</p> <p>The Foundation meets on an as needed basis (2 to 3 times a year) and holds an annual Public Meeting in December each year. The Board is composed of five members, all volunteers, each of whom serve three year terms.</p>
