- O For a Pre-existing STR:
 - a) Proof satisfactory to the Director that the STR was in operation prior to the passing of Zoning By-law Amendment 35 of 2025 (for a new licence); or,
 - b) Proof satisfactory to the Director that the property has continued to be used as a STR since the passing of Zoning By-law Amendment 35 of 2025 (for a licence renewal).
