CAPACITIES – as per By-law 63 of 2025

Full Plots:

Not more than one burial shall be made in any single grave except:

- The cremated remains of not more than four persons.
- Or a 60.96 x 30.48 cm (24" x 12") infant container or the cremated remains of one person may be buried at the head end of a single grave in which a casket containing human remains has been buried provided space is available.

Infant / Cremation Plots:

Ranges One and Two are designated for Cremation or Baby/Infant Lots, one lot can contain the remains of four persons or the cremated remains of two persons and one baby-infant container 60.96 cm x 30.48 cm (24" x 12").

Niche:

Each niche in the columbarium will allow for the inurnment of the cremated remains of no more than two people.
