The subject property is zoned Industrial 1 (M1). The following variances from Zoning By-law 97 of 2003 have been requested for a proposed workshop addition.



PLAN 533 LOT 6 Town of Plympton-Wyoming 3209 Egremont Rd

The subject property is zoned Residential 5 (R5). The following variances from Zoning By-law 97 of 2003 have been requested for a proposed Second Accessory Dwelling:

- 1) A variance of approximately 3.50 metres (11.48 feet), to allow the rear yard setback to be approximately 4.50 metres (14.76 feet), notwithstanding the maximum permitted rear yard setback of 8.00 metres (26.25 feet), and a variance of approximately 1.00 metres (3.28 feet) to allow the interior side yard setback to be approximately 1.40 metres (4.59 feet) notwithstanding the maximum permitted interior side yard setback of 2.40 metres (7.87 feet). Maximum setback provisions as per Section 3.8 Subsection r) and Table "A".
- 2) A variance of approximately 19.10 square metres (205.59 square feet), to allow the maximum gross floor area of an accessory dwelling to be approximately 65.10 square metres (700.73 square feet) notwithstanding the maximum permitted gross floor area of an accessory dwelling of 46.00 square metres (495.14 square feet) as per Section 3.8 Subsection I).
- 3) A variance of approximately 40.60 square metres (437.01 square feet), to allow the Total Lot Coverage of the Accessory Buildings on the Property to be approximately 133.60 square metres (1,438.05 square feet), notwithstanding the Maximum Lot Coverage of Accessory Buildings of 93.00 square metres (1001.04 square feet) as per Section 3.3.4 Subsection a) ii).


